#### Requirements:

- Entries must be original photos shot by APFCU, HNGCU or OTSECU members or joint account owners.
- Entries must be high-resolution (such as 300 dpi) photos in jpg format. Make sure your smartphone is on HDR (high definition) or your digital camera is on its highest setting so that your photo can be reproduced at its best in our 12 inch x 9 inch calendar. Images should be at least 2 MP and up to 7 MP.
- Entries must be in horizontal/landscape form, suitable for a wall calendar design.
- If a photo includes identifiable persons, it is the entrant's responsibility to have signed a model release from each of those persons; and to send the releases to APFCU within 1 week of submitting the photo. Release form is attached.
- You must include a 1-paragraph explanation or description of the photo.
