### CORONAVIRUS PRECAUTIONS

As the world faces the threat of the coronavirus, we are taking precautions to ensure the safety of employees, members and your finances.

Staff were advised to communicate possible exposures, remain at home if feeling sick, avoid non-essential travel and follow heightened disinfecting procedures. Temporarily reduced branch hours and a few closures are already in effect.

To help members who might need financial assistance and peace of mind, we are offering a number of relief measures (see article at right). Remember that your credit union is always ready to help.

Stay well, take health precautions and let's get through this crisis together.

## ASSISTANCE DURING THE CORONAVIRUS CRISIS: WE'RE READY TO HELP

Aloha Pacific FCU is offering a number of relief measures for members who find themselves in financial difficulty because of the coronavirus pandemic. All are now in effect through May 31:

- Early withdrawal fees are waived for certificates and withdrawals are allowed for Holiday Savings accounts
- Aloha Rewards Checking's 12 debit transactions requirement is waived
- ATM fees are waived
- \$2 Insufficient Funds (NSF) transfer fee from savings account is waived
- NSF/Overdraft Privilege fee will be reduced
- Foreclosures and repossessions temporarily halted
- Late-payment fees for existing loans are waived

- Up to 90-day extension for existing loans
- New 12-month hardship loan: up to \$1,000 interest-free and no payments for 90 days, for affected members

At the branches, heightened disinfecting measures and an emphasis on social distancing are in effect. As part of the recent stay-at-home directives, members are encouraged to limit their travel whenever possible, and bank through APFCU's online and mobile banking platforms instead of visiting a branch.

Your money is safe. As always, funds up to \$250,000 are insured by the federal government.

### REDUCED BRANCH HOURS IN RESPONSE TO CORONAVIRUS
