FINANCIAL LITERACY AND SCAM AWARENESS

April is Financial Capability Month, formerly known as Financial Literacy Month.

Don't forget that Aloha Pacific FCU offers some basic tools and reminders through our online financial education program, *https://aloha-pacific-federal.everfinext.net/welcome/financial-education*, which is free to all, members and non-members.

Topics include Adulting 101, Owning a Home, Preparing for Retirement, Financial Caregiving and small business guidance. Check out the "playlists" at your own pace and convenience. Repeat: It's free!

We also want to keep you informed about scammers who are determined to steal your money:

- NEVER respond to or click any link in an unsolicited email or text.
- Scammers are able to "spoof" phone numbers, including our own 808-531-3711. Recently, criminals have been calling with the faked number and

claiming to be from APFCU's "Fraud Department." This is a scam. Hang up. If you have any concerns, dial us directly at 808-531-3711.

- Another recent scam is an email or text notification about money waiting to be collected from Zelle. This also is a scam; do NOT click on any link. Access APFCU's Zelle service only through online banking or our mobile app.
- Beware of the fake employer/money mule scam, used by criminals to launder funds. The scenario is something like this:
 - You receive a random email or social media contact that promises easy money for little or no effort.
 - You are asked to deposit money into your account or to create a new account, where you will receive funds. Your fake employer might ask for your ID and password in order to access the money directly; or you are told to move the money through wire transfer, gift cards or



other money services.

• You are told you can keep a portion of the money you transfer.

Don't do it! You can be prosecuted as part of a criminal laundering scheme even if you didn't know you were committing a crime.

Don't be a victim. Always remember, if it sounds too good to be true, it probably is a scam.

- Direct deposits must total at least \$500 a month
- May be combined from multiple sources – including employment payroll and retirement benefits such as Social Security income – to meet the \$500 minimum



Please note that scholarship awards are restricted to one award per primary member per lifetime so that we may assist as many members as possible.

Eligibility requirements include:

 APFCU primary membership in good standing: at least \$5 in your savings account and no loan delinquencies for at least one year prior to July 21, 2024 (joint account owners are not eligible)

 Enrollment full time in an accredited program, such as an associate, baccalaureate or graduate degree

Recipients must be available in mid to late summer for picture-taking and to pick up their awards. Pending health guidelines, recipients may be asked to submit high-resolution portraits instead.

Some restrictions apply. See scholarship application for details.

ABANDONED PROPERTY NOTICE

Financial institutions, including Aloha Pacific FCU, are required by state law to annually submit abandoned property to the states of our member's last known physical address. The law defines an account with no activity for three or five years as abandoned property. The timeframe depends on the state (Hawaii, California, etc.) of the member's last known physical address.

As a courtesy, members with accounts that are considered abandoned property will be sent letters in July and August. Letters to California accounts will be sent letters in April and May.

If you receive a letter and do not respond, your inactive account may be assessed the abandoned property fee, and we will be obligated to close your inactive account and submit remaining funds to the appropriate state before the end of October.

The final deadline for California members is June 1 of the following year.

Performing at least one (1) transaction (deposit or withdrawal) annually will help keep your account(s) and membership active. In addition, be sure to keep your personal contact information up to date.

You can search online for unclaimed property at *www.unclaimed. org* and choose the state of your physical address.
